ARTICLES OF INCORPORATION
OF
A-TECH TELECOM, INC.

THE STATE OF TEXAS

COUNTY OF COLLIN

I, the undersigned, natural person of the age of nineteen (19) or more, who is a citizen of the State of Texas, acting as incorporator of a corporation under the Texas Business Corporation Act, do hereby adopt the following Articles of Incorporation for such Corporation:

ARTICLE I

The name of the Corporation is: A-TECH TELECOM, INC.

ARTICLE II

The period of its duration is perpetual, unless sooner dissolved.

ARTICLE III

The purpose for which the Corporation is organized is as follows:

The purpose for which the corporation is organized, is the transaction of any and all lawful business for which corporations may be incorporated under the Texas Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the Corporation shall have authority to issue is TEN THOUSAND (10,000) with each share to have NO PAR VALUE.

ARTICLE V

The Corporation will not commence business until it has received for the issuance of its shares consideration of the value of ONE THOUSAND DOLLARS (\$1,000.00), consisting of money, labor performed, or property actually received.
