Frazier shall perform all of the duties of a board of directors and is hereby designated as the manager of the corporation; provided, however, that the manager shall be subject to the same standards of conduct that the laws of the State of Tennessee impose upon directors in the performance of their duties.

No manager or member of the Board of Directors of the Corporation shall be personally liable to the Corporation or its shareholders for monetary damages for breach of fiduciary duty as a Manager or Director; provided, that this provision shall not eliminate or limit the liability of a Manager or Director.
