Re: Conversion of Land-To-Mobile Dialing From 7-Digits to 11-Digits

Dear Name:

At the request of the Kentucky Public Service Commission, BellSouth converted Land-to-Mobile enabled codes to standard dialing plans beginning February 28, 2003. These translations changes to NPAs 270, 606, and 859 were made in BellSouth's central offices, as scheduled.

Since February 28th, we have learned that errors were made in some of those translations. This prompted a review of all the translations made in all offices throughout the state which revealed errors that affect the way calls are dialed to 49 wireless NXXs. A list of the codes affected is attached.

In each case, the translations expanded the dialing pattern from 7 digits to 11 digits, but blocking of 7-digit dialing was not implemented. As a result, in these offices, land-to-mobile calls may be dialed using either 7-digit abbreviated dialing or 11-digit standard dialing.

BellSouth plans to correct these translations over the period of August 1, 2003 through October 1, 2003. We have chosen to begin on August 1st is for two reasons:

- 1. To provide the wireless carriers involved time to re-notify their customers, should they choose to, before the translations are changed.
- 2. To allow BellSouth to coordinate these corrections with the conversion from permissive (abbreviated) dialing to standard dialing plans across its entire nine-state region.

We regret any confusion and inconvenience this oversight in translations may have caused customers, the Commission, and the carriers involved.
