On February 23, 2006, CTC Communications Group, Inc. ("CTC"), CTC Communications Corp., ("CTC Communications") and Choice One Communications Inc. ("Choice One"), by their counsel, filed an a Notification regarding a transfer of control transaction.

On April 7, 2006, CTC Communications Group, Inc. ("CTC"), CTC Communications Corp. ("CTC Communications"), Choice One Communications Inc. ("Choice One"), Conversent Communications, Inc. ("Conversent"), and FiberNet, LLC ("FiberNet") (collectively, the "Parties"), by their counsel, filed a Notification regarding a transfer of control transaction.

This letter is to advise the Commission that the transactions that were the subject of the Notifications have been consummated.

As described in the Notifications, CTC has merged with and into Choice One (the "Merger"), with the corporation surviving the Merger – now called One Communications Corp. - becoming the new ultimate parent company of the Parties. This change in control did not involve the transfer of operating authority, assets or customers – the Parties will continue to offer the same services at the same rates, terms and conditions.
