**SECTION 63.71 APPLICATION**

CenturyLink Communications, LLC (FRN: 0018-4219-41), f/k/a Embarq Communications, LLC and also f/k/a Qwest Communications Company, LLC d/b/a CenturyLink QCC (referred to herein as “CenturyLink”) hereby applies for authority to discontinue various Voice over Internet Protocol (VoIP) services that have operated on a VoIP platform (Sylantro) that is no longer technically supported. CenturyLink requests authority from the Federal Communications Commission (“Commission”) to discontinue this service as of October 1, 2018.

CenturyLink submits the following information in support of its application:

**1. Name and address of carrier**

## **2. Date of planned service discontinuance**

CenturyLink plans to cease offering the services supported by the Sylanro VoIP platform on October 1, 2018, or as soon thereafter as the necessary regulatory approvals can be obtained.

After this date, CenturyLink will discontinue offering the services supported by the Sylanro VoIP platform to any new customers. Existing Sylanro VoIP platform services will maintain their existing product configurations for the duration of the customer's current service contract term, however, existing customers will not be able to make moves, adds or changes to the service. Existing customers will be able to continue with their current service with no changes. If the existing customer decides to move to the new platform, they will sign a new contract and CenturyLink will waive any early termination penalties on their old contract.

## **3. Points of geographic areas of service affected**

CenturyLink seeks authority to discontinue offering services supported by the Sylanro VoIP platform in all 50 states and Washington D.C.

## **4. Brief description of the type of services affected**

The Sylanro VoIP platform has reached its end of life and CenturyLink is seeking to discontinue the VoIP services provided by the platform, which are:

- Qwest OneFlex Hosted VoIP: An IP application that provides real-time, two-way voice capability in IP over a broadband connection.
- Qwest OneFlex Integrated Access – Analog and Digital: An IP-based solution that integrates local and long-distance voice with Internet access on a single connection.
- Qwest Managed VoIP: An IP application that provides real-time, two-way voice capability in IP over a broadband connection.
- Qwest Hosted VoIP: An IP application that provides real-time, two-way voice capability in IP over a broadband connection.
- Qwest IQ Managed VoIP Bundle: An IP application that provides real-time, two-way voice capability in IP over a broadband connection.
- IQ Integrated Access Packages: An IP-based solution that integrates local and long-distance voice with Internet access on a single connection.
- IQ Integrated Access Analog: An IP-based solution that integrates local and long-distance voice with Internet access on a single connection.

- IQ Integrated Access Digital: An IP-based solution that integrates local and long-distance voice with Internet access on a single connection.
- Core Connect Enterprise Integrated Access (IA) (\*services sold before December 31, 2015): An IP-based solution that integrates local and long-distance voice with Internet access on a single connection.
- Fiber+ Integrated Access (IA) (\*services sold before December 31, 2015): An IP-based solution that integrates local and long-distance voice with Internet access on a single connection.
- Fiber+ Enterprise Integrated Access (IA) (\*services sold before December 31, 2015): An IP-based solution that integrates local and long-distance voice with Internet access on a single connection.
- CenturyLink Managed VoIP: An IP application that provides real-time, two-way voice capability in IP over a broadband connection.
- CenturyLink Integrated Access -Analog: An IP-based solution that integrates local and long-distance voice with Internet access on a single connection.
- CenturyLink Hosted VoIP (BroadSoft): (sold before August 30, 2014 in Florida, Missouri, North Carolina, Nevada, Ohio, Tennessee and Texas) An IP application that provides real-time, two-way voice capability in IP over a broadband connection.

\* Note: Services sold after December 31, 2015 were provisioned on a newer VoIP platform and are not included in this application.

Customers will be able to maintain their current product configurations for the duration of their current service terms. Customers will also be able to transition to other VoIP solutions offered by CenturyLink on a new VoIP platform with new technology, capabilities and features.

- IQ SIP Trunk (native SIP or PRI handoff)
- Core Connect Enterprise – Integrated Access
- Fiber + Integrated Access (IA)\*
- Fiber+ Enterprise Integrated Access (IA)\*

## **5. Brief description of the dates and methods of notice to all affected customers**

CenturyLink notified its customers who have services supported by the Sylanro VoIP platform by U.S. mail on August 13 and August 17, 2018, as shown in Attachments A and B.

**6. Dominance of carrier with respect to the service to be discontinued**

CenturyLink is a non-dominant carrier with regard to services supported by the Sylanro VoIP platform.


**7. Service**
