APPLICATION OF CINERGY BROADBAND, LLC FOR DETERMINATION OF STATUS AS AN EXEMPT TELECOMMUNICATIONS COMPANY

Pursuant to Section 34(a)(1) of the Public Utility Holding Company Act of 1935 ("PUHCA"), as amended by Section 103 of the Telecommunications Act of 1996, Cinergy Broadband, LLC, a Delaware limited liability company ("Applicant") hereby applies for a determination that it is an "exempt telecommunications company" ("ETC") within the meaning of Section 34(a)(1) of PUHCA. Applicant is an indirect subsidiary of Cinergy Corp. ("Cinergy"), a Delaware corporation and a registered holding company under PUHCA.

In support of this application, Applicant states as follows:

- 1. Applicant will be engaged directly, or indirectly through one or more affiliates (as defined in Section 2(a)(11)(B) of PUHCA), and exclusively in the business of providing: (A) telecommunications services; (B) information services; (C) other services or products subject to the jurisdiction of the Commission; and/or (D) products or services that are related or incidental to the provision of a product or service described in (A), (B) or (C) above.
 - 2. The following briefly describes the Applicant and its planned activities:

Applicant has been formed for the purpose of holding an interest in entities that provide broadband communications services, enhanced power distribution services and other data detection and transmission services.

3. In addition to or in lieu of the activities just described, Applicant may in the future engage in such other business activities as are consistent with the definition of an ETC set forth in Section 34(a)(1) of PUHCA.

- 4. Applicant, as a corporate entity, certifies that no party (as defined in 47 C.F.R. §1.2002(b)) is subject to a denial of Federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. §853(a).
- 5. Concurrently with the submission hereof to this Commission, Applicant is providing copies of this application to the Securities and Exchange Commission and the affected state commissions, namely, the Public Utilities Commission of Ohio, the Indiana Utility Regulatory Commission and the Kentucky Public Service Commission.
- 6. Applicants request that any communications regarding this application be made to the following individuals:
