
Pursuant to Administrative Case No. 359, please accept this letter as notification that Communications Network Billing, Inc. is transferring control to Cristina M. Tucker ("Tucker"). Communications Network Billing, Inc.'s tariff was filed with the Commission effective December 18, 2003.

Pursuant to the Stock Purchase Agreement, Cristina Michele Tucker will acquire control of CNBI through the purchase of 100% of the issued and outstanding stock of C. Hurley Cox. The company will continue to operate as Communications Network Billing, Inc. and only the underlying ownership of CNBI will change as a result of this transaction. The transaction will not result in a change in the manner in which CNBI provides services to its customers, in that it will continue to provide service under the rates, terms and conditions it currently offers to its customers.
