The name of the surviving corporation in the merger herein certified is "Cricket Communications, Inc.", which will continue its existence as said surviving corporation under its present name upon the effective date of said merger pursuant to the provisions of the General Corporation Law of the State of Delaware.
5. The Certificate of Incorporation of Cricket in effect as of the date of the merger shall be the Certificate of Incorporation of the surviving corporation unless and until amended in accordance with its terms and applicable law.

6. The executed Merger Agreement is on file at the principal place of business of Cricket, the address of which is as follows:


