OnStar, LLC ("OnStar"), by its undersigned counsel, hereby informs the Commission of the reorganization and exit from bankruptcy under Chapter 11 of the U.S. Bankruptcy Code of its parent company.

OnStar is authorized to provide resold Commercial Mobile Radio Services ("CMRS") in your state.¹

On June 1, 2009, OnStar's parent company, General Motors Corporation ("GM"), filed a voluntary petition for protection under Chapter 11 of the U.S. Bankruptcy Code in the U.S. Bankruptcy Court for the Southern District of New York.² OnStar itself was not a party to the bankruptcy proceeding.³

As part of its court approved plan to exit bankruptcy, GM transferred certain assets, including OnStar, to General Motors Company ("GMC") on July 10, 2009. Further, on November 2, 2009, GMC changed its corporate structure and transferred direct ownership of


