Global Connection Inc. of Kentucky ("Global") is a certificated Competitive Local Exchange Carrier (T62-1346) providing telecommunications services to approximately 1,586 customers in Kentucky. The Company is certified in a total of 31 states. The primary business in which Global is engaged is the resell of residential prepaid telecommunications services.

This filing is simply a change in the name of the entity and is not the result of a change in control or merger/acquisition activity. SECOND: The dissolution of the Corporation was authorized on the 6th day of June, 2008.

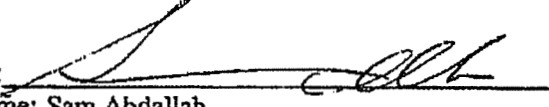

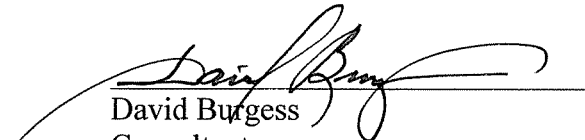
