

KENTUCKY NOTICE OF INTENT TO PROVIDE SERVICE
OF
IC FIBER KENTUCKY LLC

IC Fiber Kentucky LLC ("IC Fiber" or "Applicant"), a Delaware limited liability company wholly owned by Worldwide Fiber IC LLC, pursuant to Administrative Cases 359¹ and 370², hereby submits this Notice of Intent to provide long distance and competitive local telecommunications services to customers within the Commonwealth of Kentucky.

6. Description of Services

IC Fiber proposes to operate as a facilities-based provider of technologically advanced dark fiber and high-bandwidth fiber optic transmission capacity including high capacity interexchange and local transport on a leased long-term basis. Specifically, IC Fiber intends to offer optical transmission services, private line services, virtual switching and packet-based data services through its sale of bandwidth capacity. IC Fiber does not intend to provide operator assisted services for traffic aggregators pursuant to the provisions of Administrative Case No. 330.

7. **Tariff**


