Enclosed please find for filing, one original and four (4) copies of a Tariff Adoption Notice, new tariff and Qualification to do Business of Insight Phone of Kentucky, LLC d/b/a Insight Phone ("Insight"), in order to change the name of AT&T Broadband Phone of Kentucky, LLC ("AT&T – Kentucky") to Insight.
