On behalf of KMC Telecom IV, Inc. ("KMC IV" or the "Company"), enclosed for filing are an original and four (4) copies of this letter of intent, as well as KMC IV's proposed tariffs. In accordance with the Commission's Orders in Administrative Case No. 359 (dated June 12, 1996), Administrative Case No. 355 (dated September 26, 1996) and Administrative Case No. 370 (dated January 8, 1998), KMC IV submits the following information:

2. KMC IV, a Delaware corporation, is a wholly-owned subsidiary of KMC Telecom Holdings, Inc. ("KMC Holdings"), a Delaware corporation. A copy of KMC IV's Certificate of Incorporation is attached hereto as Exhibit A. KMC IV is in the process of applying for its Certificate of Authority to transact business in Kentucky and will forward the certificate to the Commission as soon as it is granted to be attached hereto at Exhibit A.


4. KMC IV has not provided nor collected for telecommunications service in Kentucky prior to filing this notice of intent. Please see notarized statement attached hereto at Exhibit B.
5. KMC IV does not seek to provide operator assisted services to traffic aggregators as defined in Administrative Case No. 330.
6. KMC IV proposes to provide all forms of resold and facilities-based local exchange, switched and special access, and resold interexchange services. This will be accomplished through a combination of KMC IV's own facilities and through the resale of the facilities of other certificated carriers. KMC IV therefore seeks authority to offer its services to business and residential customers as both a facilities-based carrier and a reseller of telecommunications services. KMC IV will offer services which allow its customers to originate and terminate local calls to other customers served by KMC IV as well as customers served by all other authorized local exchange carriers. KMC IV will also provide switched access services to interexchange carriers, which will allow KMC IV's customers to originate and terminate intrastate calls to and from customers of other interexchange carriers, and special access services. KMC IV's services will be available on a full-time basis, 24-hours a day, seven days a week. KMC IV intends to begin service as soon as possible after regulatory approval.
7. A copy of KMC IV's proposed local exchange and interexchange tariffs are attached hereto as Exhibits C and D respectively. KMC IV will be supplementing these tariffs to include its proposed rates under a separate cover. The tariffs have an effective date thirty (30) days from the date of this filing, which is consistent with the regulatory requirements set forth in the Commission's Order in Administrative Case No. 359, dated June 21, 1996.
