This filing incorporates the new company name. The Company respectfully requests an effective date of November 2, 2002 for this filing.

On February 12, 2002, Long Distance of Michigan, Inc. amended its Articles of Incorporation to change its name to LDMI Telecommunications, Inc. ("Company"). This name change reflects the Company's nationwide reach. The Company is currently authorized to provide competitive telecommunications services in the State of Kentucky effective July 17, 1997.

This amendment changed only the name of the corporation and did not alter any assets or holdings, the Company's corporate structure, nor its personnel, directors and officers. Additionally, the Company has not altered its service offerings or prices, so its customers should not be adversely affected by this name change. Attached as Exhibit 1, please find a copy of the Amended Certificate of Authority, Amended Articles of Incorporation and an amended Corporate qualification pertaining to the above-referenced name change.
