

# SECTION 63.71 AND SECTION 63.19 APPLICATION OF MCI COMMUNICATIONS SERVICES INC. D/B/A VERIZON BUSINESS SERVICES

MCI Communications Services Inc. d/b/a/ Verizon Business Services ("Verizon") hereby submits this Application for authority under Section 214(a) of the Communications Act and Sections 63.71 and 63.19 of the Commission's rules to discontinue providing Telex service which is offered in all fifty states, the District of Columbia, and in Puerto Rico on a domestic interstate and international basis. As required by Sections 63.71(a) and (b) of the Commission's rules, Verizon provides the following information:

## 1. Name and Address of Carrier (47 C.F.R. §§ 63.71 (a)(1), (b)(2)):

MCI Communications Services Inc. d/b/a Verizon Business Services 22001 Loudoun County Parkway Ashburn, VA 20147

## 2. Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2), (b)(2)):

The proposed discontinuance will take place on March 1, 2008, subject to the Commission's authorization pursuant to Section 63.71(c) of the Commission's rules.

## 3. Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), b(2)):

Verizon will discontinue providing Telex service in all fifty states, the District of Columbia, and in Puerto Rico, subject to the Commission's authorization of the proposed discontinuance pursuant to Section 63.71(c) of the Commission's rules.

## 4. Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(4), b(2)):

Verizon currently offers Telex service in all fifty states, the District of Columbia, and in Puerto Rico on a domestic interstate and international basis. Telex service allows subscribers to send real-time teletype messages. The public convenience and necessity will not be impaired by this proposed service discontinuance because there are several alternative providers of telex services in the United States.

# 5. Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. §§ 63.19(a), 63.71 (b)(3)):

Written notification of the proposed discontinuance to the affected customers was mailed to the affected customers on December 27, 2007. The affected customers will receive written notification ("Notice") in the mail more than 60 days before the proposed discontinuance. The Notice informs the affected customers that alternative service options exist. A copy of the Notice sent to the affected customers is attached to this Application.

Copies of this Application are being sent via first class U.S. Mail to the governor and public utilities commission for each affected state and also to the Special Assistant for Telecommunications to the Secretary of Defense, as required by Section 63.71(a) of the Commission's rules.

# 6. Regulatory Classification of Carrier (47 C.F.R. § 63.71(b)(4)):

Verizon is considered non-dominant with respect to the service to be discontinued.

## CONCLUSION

Verizon respectfully requests that the Commission approve this Application requesting authority under Sections 63.71 and 63.19 of the Commission's rules to discontinue providing Telex service nationwide.

As you were previously advised, and as part of its effort to focus on services that best meet the demand of its customers, Verizon Business intends to decommission its existing Telex Service on March 1, 2008.

The Telex Service is offered throughout the country on an interstate basis, and is also offered internationally. The service provides customers with messaging capabilities offered by foreign Postal, Telephone, and Telegraph (PTTs) service providers. Verizon Business operates its own telex exchange and provides direct connectivity to foreign telex exchanges around the world. The service allows users to send teletype messages with global coverage. The demand for the Telex Service, which has been offered for fifty years, has diminished significantly over the past few years and is being replaced by email and Internet services. Presently, Verizon Business has fewer than 100 customers for this service. These customers have other service options available to them as several providers offer reasonable service alternatives.

The FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments within 15 days after receipt of this notification. Address them to the Federal Communications Commission, Washington, D.C. 20554, referencing the Section 63.71 Application of MCI Communications Services Inc. d/b/a Verizon Business Services. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.

If you would like to transition your Telex Service to another provider, we suggest you do so as soon as possible. As Verizon Business' Telex Service will be discontinued on March 1, 2008, to avoid a potential lapse in service, you should place an order for disconnection well in advance of that date. If you fail to choose another provider for your Telex Service by the proposed discontinuance date, you will **NOT** automatically be transferred to another provider.
