
Pursuant to Administrative Case No. 359, please accept this letter as notification that Boyan Josic ("Josic"), President of Network Service Billing, Inc. ("NSBI") is transferring control to Peter A. Lagergren ("Lagergren"). Network Service Billing, Inc.'s tariff was filed with the Commission effective June 15, 2005.

Pursuant to the Stock Purchase Agreement, Peter A. Lagergren will acquire control of NSBI through the purchase of 100% of the issued and outstanding stock of Boyan Josic. The company will continue to operate as Network Service Billing, Inc. and only the underlying ownership of NSBI will change as a result of this transaction. The transaction will not result in a change in the manner in which NSBI provides services to its customers, in that it will continue to provide service under the rates, terms and conditions it currently offers to its customers.


