RE: Informational Filing Regarding NuVox Communications, Inc

Dear Mr. Derouen:

Pursuant to the Commission's January 8, 1998 Order in Administrative Case No. 370, we are providing an informational notice to the Commission regarding a transaction involving the ultimate parent company of NuVox Communications, Inc. ("NuVox Communications"). NuVox Communications is a competitive local exchange carrier certificated to provide service in Kentucky, and its ultimate parent company is NuVox, Inc.¹ As a result of the transaction, Nuvox, Inc. will become the direct, wholly-owned subsidiary of Windstream Corporation ("Windstream"), and Windstream, therefore, will be the new ultimate parent company of NuVox Communications. (For the Commission's convenience, a set of diagrams showing the pre- and post-Transaction corporate structure of NuVox as well as the transaction is appended hereto.)

This change in ultimate control does not involve a transfer of operating authority, assets or customers, and the transaction is expected to be seamless to end user customers. Following consummation of the transaction, NuVox Communications will continue to offer the same services, rates, terms and conditions pursuant to its existing authorization. The current customers of NuVox Communications will remain customers of NuVox Communications. Accordingly, the transaction will be virtually transparent to Kentucky customers, who will continue to enjoy the same rates, terms and conditions of service as they do prior to closing.² Because NuVox Communications will continue its corporate existence and current operations, including existing




