NOTICE OF NAME CHANGE AND PARTIAL OWNERSHIP CHANGE

Operator Service Company, a Texas corporation, ("OSC") provides notice of a transfer of equity interest transaction between BC Holding III Corporation and Onslow Holdings, LLC, a California limited liability company, ("Buyer"). As a result of this transaction OSC became a minority-owned subsidiary of Buyer, but will continue to operate as a separate entity. OSC is currently certificated to provide intrastate interexchange telecommunications services in Kentucky and will retain its status as a telecommunications services provider in Kentucky. OSC has changed its domicile to a Delaware limited liability company, known as Operator Service Company, LLC.

I. DESCRIPTION OF TRANSACTION

Buyer is a company formed under the laws of California with its principal office located in California. A copy of the certificate of formation is included as Exhibit 1. Buyer is not a certificated entity in the State of Kentucky and has not registered to do business in Kentucky as a foreign entity. Buyer is a holding company organized for the purpose of holding an equity interest in OSC.

On July 19, 2004, BC Holding III Corporation and Buyer entered into an agreement (the "Agreement"), pursuant to which Buyer will own a 49% interest in OSC. OSC remains a separate operating company.

II. CUSTOMER IMPACT

OSC remains a separate certificated company in the State of Kentucky. This transaction has no effect on the rates or terms and conditions of service. The toll free telephone number for customer service will remain the same: 800-658-6041. OSC has changed its domicile to be a Delaware limited liability company in connection with this transaction.
