**COMPETITIVE LOCAL EXCHANGE AND INTEREXCHANGE SERVICES**


Pursuant to the rules of the Kentucky Public Service Commission (the "Commission"), Prepaid Telecom, Inc. (Prepaid) submits this Petition to Discontinue Competitive Local Exchange and Interexchange Services, and in support thereof states as follows:

1. Prepaid was granted authority to provide local exchange telecommunications service in Kentucky and the Commission stamped Prepaid's tariff on February 1, 2002.
2. Due to a change in business plans, Prepaid now wishes to relinquish its certificate to provide said services in Kentucky. Prepaid no longer wishes to provide telecommunications services to customers in Kentucky.
3. Prepaid further states that it no longer has any customers in Kentucky, so there are no Kentucky customers affected by Prepaid's Petition.
4. Because it serves no customers in Kentucky, Prepaid has no customers in Kentucky to notify of its plans to discontinue local telephone service pursuant to the Commission's Rules.

WHEREFORE, Prepaid Telecom, Inc. prays that the Commission grant this Petition to Discontinue Competitive Local Exchange Services; that the Commission cancel it's tariff stamped by the Commission on February 1, 2002; and that the Commission grant all other necessary and proper relief.




