## Dear Mr. Derouen:

Trans National Communications International, Inc. ("TNCI" of "Company"), by its regulatory consultants, herby respectfully requests that its registration for the provision of commercial mobile radio services ("CMRS", identified by the Kentucky Public Service Commission ("Commission") as "9414 Cellular" registration), be withdrawn. In support of its request, TNCI states as follows.

TNCI is currently designated by the Commission as a "multi-service utility" with authority to provide competitive local exchange, interexchange, and Cellular/CMRS services in Kentucky. TNCI's pursuit of Cellular/CMRS authority had been predicated upon the Company's planned entry into the CMRS market as a non-facilities-based CMRS reseller. The Company has since refocused its strategy and determined that it no longer wishes to pursue the CMRS market in Kentucky. In order to relieve itself from the ongoing administrative obligations associated with the holding of CMRS authority, TNCI respectfully requests that its CMRS authority now be withdrawn. TNCI stresses that the instant request is limited *exclusively* to its CMRS authority and not to separate authority held by TNCI for the provision of competitive local exchange and interexchange authority.

TNCI maintains that its request is purely an administrative matter. TNCI does not now, nor has it at any time, provided CMRS services in Kentucky. The Company has no CMRS subscribers in Kentucky. No member of the public will be affected by the Company's request for revocation of its CMRS authority.
