Dear Mr. Dorman:

On June 17, 2002, ACSI Local Switched Services, Inc., d/b/a e.spire, American Communication Services of Lexington, Inc., d/b/a e.spire and American Communication Services of Louisville, Inc., d/b/a e.spire (together, the "e.spire Operating Entities"); and Xspedius Management Co. Switched Services, LLC, Xspedius Management Co. of Lexington, LLC and Xspedius Management Co. of Louisville, LLC (together, the "Xspedius Operating Entities"), by their attorneys, filed a Notification with the Kentucky Public Service Commission ("Commission") regarding the transfer of substantially all of the assets, including the customer contracts, of the e.spire Operating Entities to the Xspedius Operating Entities and the discontinuance of telecommunications service by the e.spire Operating Entities in the Commonwealth of Kentucky. The Commission authorized the Xspedius Operating to provide facilities-based and resold local exchange and interexchange telecommunications service on August 4, 2002, as necessary to serve the former customers of the e.spire Operating Entities in Kentucky.

This letter is to advise the Commission that the transaction that was the subject of the Notification is complete. The Xspedius Operating Entities currently are serving the former customers of the e.spire Operating Entities in Kentucky. At this time, the e.spire Operating Entities no longer are providing telecommunications service to customers in Kentucky, and understand that their tariffs have been adopted by the Xspedius operating entities accordingly.
