Enclosed for filing, please find the original and three (3) copies of this letter and enclosed replacement tariffs submitted on behalf of Time Warner Telecom of Kentucky LLC as notification to the Commission that the Company is changing the name under which it will provide telecommunication services within the State of Kentucky to **tw telecom of kentucky llc**. Also included with this filing is documentation issued by the Kentucky Secretary of State's Office regarding the name change.

This name change does not affect the rates, terms or conditions of services currently provided to the Company's Kentucky's customers; accordingly no changes have been made to the tariff's rates, terms or conditions of service. No changes have been made to the tariffs except to reflect the Company's new name. The Company respectfully requests July 27, 2008 as the effective date for the enclosed tariffs.

Dear Ms. Stumbo,

Time Warner Telecom, Inc. ("TWT"), the ultimate owner of Time Warner Telecom of Kentucky LLC, has announced that it will change its name to tw telecom inc., effective July 1, 2008. As part of that transition, TWT is changing the names of various subsidiaries and affiliates, including Time Warner Telecom of Kentucky LLC. In the interim, Time Warner Telecom is co-branding with the tw telecom name while completing necessary legal and regulatory requirements and marketing and communications activities.

That process has begun in Kentucky. On March 26, 2008, Time Warner Telecom of Kentucky LLC filed an Application for Amended Certificate of Authority with the Kentucky Secretary of State's Division of Corporations. A copy of that filing is enclosed. That filing reflects that Time Warner Telecom of Kentucky LLC has already changed its name in its state of organization, Delaware, to tw telecom of kentucky llc.

Customers received written notice of the upcoming name change on March 14, 2008. In addition, invoices for April, May and June 2008 will include a bill message concerning the name change.
