NOTICE

Beech Grove Water System has filed with the Public Service Commission to pass through a rate increase it received from its wholesale water supplier, City of Henderson which began with March 2020 consumption. This results in a .28 cent per 1,000 Gallons increase effective March 15, 2020 that will be reflected on Beech Grove Water System customer bills due in April 2020.
