Crown Fiber's business is building communications solutions for enterprise and carrier customers individually for each project's needs. The Company intends to provide primarily facilities-based Dark Fiber, Private Line, Ethernet, Wavelength, Dedicated Internet Access and Collocation services to wholesale (e.g., other carriers) and customers in government, health care, education, financial services, and other enterprises.
