KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, Mr. L. Ray McDaniel is a resident of Jefferson County, Kentucky, and having attained the age of more than twenty-one (21) years, do hereby form a corporation under the laws of the Commonwealth of Kentucky.

ARTICLE I

The corporation shall be named and known as Mac's Telephone Contracting, Inc. by which name it may adopt a corporate seal, conduct its business, contract and be contracted with, sue and be sued.

ARTICLE II
