**Re: Accelecom GA LLC
Notification of Intent to Provide Intrastate Telecommunications Services
in the Commonwealth of Kentucky**

Dear Ms. Bridwell:

On behalf of Accelecom GA LLC ("Accelecom" or the "Company"), enclosed for filing is Accelecom's notification of its intent to operate as a Competitive Local Exchange Carrier and Interexchange Carrier within the Commonwealth of Kentucky. The Company intends to provide services to and from all points within Kentucky and therefore seeks statewide authorization. In accordance with the Commission's Orders in Administrative Case No. 359 and Administrative Case No. 370, Accelecom submits the following information:

4. A notarized statement by an officer of the utility that the utility has not provided or collected for intrastate service in Kentucky prior to filing the notice of intent or, alternatively, a notarized statement by an officer that the utility has provided intrastate services, that it will refund or credit customer accounts for all monies collected for intrastate service.

The Company has not provided nor collected for intrastate telecommunications service in Kentucky prior to filing this notice of intent. A notarized statement by an officer of the Company attesting to such is attached as **Exhibit C**. The Company intends to provide service to end users, primarily point-to-point transmission services, but may offer additional services.

5. A statement that the utility does not seek to provide operator assisted services to traffic aggregators as defined in Administrative Case No. 330 or, alternatively, that the utility does seek to provide operator assisted service to

traffic aggregators but that in so doing it is complying with the Commission's mandates in Administrative Case No. 330.

The Company does not seek to provide operator assisted services to traffic aggregators as defined in Administrative Case No. 330. A notarized statement by an officer of the Company attesting to such is included as **Exhibit C**.

6. The Company's proposed tariffs are attached as exhibits. Or in the alternative, if the Company is not providing tariffs, indicate the website address of the company's price schedule and the manner in which it intends to inform customers of applicable service arrangements.

The Company does not plan to provide basic telecommunications nor switched access services and is therefore not providing a tariff with this notice. Rather, the Company will operate on a de-tariffed basis pursuant to KRS 278.541 to 278.544. The Company's services will be provided on an individual contract basis, with each customer negotiating terms for their particular services. Service will be offered on a non-discriminatory basis to similarly situated customers in substantially similar circumstances. As stated above, EAE will not offer basic local exchange services at this time. If in the future EAE offers basic local exchange services it will comply with all tariffing requirements. In lieu of a tariff, the Company intends to post the terms, conditions, and rates for services it provides on its website at accelecom.net.

7. A sample Company bill:

A sample customer bill is attached as **Exhibit D**.

8. If the company is requesting CLEC authority please indicate if an interconnection agreement has previously been filed with the Commission or if one will be filed in the future.

At this time, the Company only seeks authority to provide local exchange telecommunications services that do not require an interconnection agreement in Kentucky.

In addition, the Information Form for Telephone Utilities Operating Pursuant to KRS 278.541 through 278.544 is provided as **Exhibit E**.
