All solar infrastructure shall be at least 200 feet from the project's external property boundaries and 300 feet from any neighborhood, with the exception that central inverters be located at least 450 feet from any residence. 4. Turkey Creek's petition for reconsideration and clarification filed on October 19, 2020, is granted in part and denied as moot in part, as detailed above. 5. Turkey Creek's motion for decision filed on March 24, 2021, is denied as moot. |
