- (4) The remaining \$1,000,000 of the civil penalty is suspended on the condition that South Kentucky abide by the terms contained in the Settlement Agreement, provide all required documentation within the time allotted and does not have any related reportable incidents investigated by the PSC.
- (5) Within 30 days of the date of this Order, South Kentucky shall provide documentation on the safety meeting conducted on June 21, 2011.
- (6) Within 30 days of the date of this Order, South Kentucky shall provide minutes from its August 25, 2010 hazardous recognition training .
- (7) On or before February 1, 2012, South Kentucky shall provide a summary report of the 50 clearance issues that have been found by South Kentucky since 2008.
