- 6. Bracken shall furnish documentation of the total costs of this project within 60 days of the date that construction is substantially completed.
- 7. Bracken shall file a copy of the "as-built" drawings and a certified statement that the construction has been satisfactorily completed within 60 days of the substantial completion of the construction.
- 8. Bracken shall require the construction to be inspected under the supervision of a licensed professional engineer with a Kentucky registration.
- 9. Bracken is authorized to enter the proposed Assistance Agreement with KIA to borrow an amount not to exceed \$475,000.
- 10. Bracken is authorized to enter the proposed Assistance Agreement with KIA to borrow an amount not to exceed \$621,000.
- 11. As Bracken receives any principal forgiveness, it shall debit the appropriate Long Term-Debt Account and make a corresponding credit entry to Account 271.
- 12. Within 30 days of executing its proposed Assistance Agreements with KIA, Bracken shall advise the Commission .
