ORDER

On August 30, 2024, the Commission issued a final Order in this matter approving adjustments to water service rates for Estill County Water District No.1 (Estill District No.1) in its application for a rate adjustment pursuant to 807 KAR 5:076. Subsequently, on September 20, 2024, Estill District No.1 filed into the post case record a motion to amend the August 30, 2024 Order¹ (Motion) that requested the Commission amend, *nunc pro tunc*, its August 30, 2024 final Order by removing references to the authorized Bulk Loading Station Rate. As grounds for its Motion and for removing the Bulk Loading Station Rate, Estill District No.1 stated, "(a) its bulk loading station is no longer operational; (b) the District has received no customer requests for such service; (c) the District received no revenue from any bulk loading station during the test period and did not anticipate any revenue from such rate in the future; and (d) elimination of the rate will have no effect on the billing and revenue analyses submitted with the District's application."²

Commission regulation 807 KAR 5:001, Section 5(1), states that all requests for relief that are not required to be made in an application, petition, or written request shall be made by motion, and the motion shall state precisely the relief requested.

Being otherwise sufficiently advised, the Commission finds that Estill District No.1 stated sufficient grounds for its Motion and precisely stated the relief requested. Therefore, Estill District No.1's Motion should be granted and the August 30, 2024 final Order should be amended.

Accordingly, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

- 1. The rate Appendix B to the August 30, 2024 final Order is stricken and is replaced with the Appendix to this Order.
- 2. The adjusted rates in the Appendix to this Order are fair, just and reasonable.
- 3. All other provisions of the Commission's August 30, 2024 Order that are not in conflict with the terms of this Order shall remain in effect.
- 4. Within 20 days of the date of service of this Order, Estill District No.1 shall file with the Commission revised tariff sheets containing the approved rates.
