Re: Merger between AT&T, Inc. and BellSouth Corporation

Dear Ms. O'Donnell:

I am pleased to inform you that the merger between AT&T Inc. and BellSouth Corporation closed on December 29, 2006, at which time BellSouth Corporation became a wholly-owned, first-tier subsidiary of AT&T Inc.

As a result of the merger at the holding company level, BellSouth Telecommunications, Inc. will adopt the AT&T brand name for its products and services. The transition from the use of the BellSouth brand name to the AT&T brand name is expected to occur over the next few months.

To that end, BellSouth Telecommunications, Inc. ("BellSouth") hereby notifies the Commission that it will use the doing business as ("d/b/a") names of "AT&T Kentucky" and "AT&T Southeast." While BellSouth Telecommunications, Inc. will remain a corporate entity certificated in Kentucky, BellSouth will do business under the d/b/a names of "AT&T Kentucky" and "AT&T Southeast."

BellSouth is also filing the required papers with the office of the Secretary of State to use the identified d/b/a names in Kentucky. A copy of those papers is attached hereto as Exhibit A.

With regard to the tariffs, BellSouth is filing concurrent with this d/b/a notice new tariff cover pages reflecting the names under which BellSouth will be doing business in Kentucky.

The address of the post-merger operating company and the company contact information on file with the Commission remain unaffected by this d/b/a notice.
